Such permission must be obtained from the copyright owner, heir(s) or assigns.

"Courtesy of John Carl Warnecke Architectural Archives" or "Courtesy of Carl I. Warnecke Architectural Archives" must be indicated below the image each time the image appears in the publication. The Warnecke Architectural Archives retains all copyrights to images.
